



WEEKLY UPDATE AND NOTIFICATION OF NEW CASES

Dear Residents and Families/Representatives,

Please accept this letter as our weekly update regarding the status of COVID-19 in our facility. Since the onset of this virus, we have had 51 residents and 40 staff members test positive for COVID-19. All have recovered, with the exception of four newly positive residents that are isolated in our COVID positive unit. The positive employee is still quarantining at home.

Due to Clark County’s positivity rate reaching 11.6%, facility staff will be tested twice weekly until further notice.

At this time, we are CEASING our outdoor visitation as we continue to test all staff for COVID-19. We will accommodate compassionate visits for our residents who are on Hospice. We will still schedule visits beginning the week of November 23, 2020, however, those visits are subject to cancellation pending test results. Visits are by appointment only. Please contact Reception to schedule your visit: 702-382-5580. We are allowing 30-minute

visits; visitors will be screened, will be required to wear a mask and keep socially distanced from your loved one. Noncompliance with these basic precautions will result in facility staff terminating the visit.

As always, we are working hard to keep everyone in our community safe and we will continue to practice the enhanced safety precautions that are known to prevent the spread of COVID-19, such as only essential personnel are allowed inside the facility and we screen them for signs and symptoms of illness prior to entering. Our residents are continually monitored and staff is using PPE as recommended by the CDC. Staff is frequently reminded and encouraged to practice social distancing and to use hand sanitizer and frequently wash their hands when they are in the facility and out in the community. We ask them not to report to work if they have symptoms of illness.
